- 2. As one of the measure to comply with the said Convention, the Directorate has also granted approval of two additional batches in a week, of 'Ship Security Officer's [SSO] Course to all the SSO approved maritime training institutes, vide Training Circular No.22 of 2013 dated 10.12.2013 read with Training Circular No.20 of 2013 dated 11.11.2013, which was valid upto 5.4.2014.
- 3. In order to facilitate the seafarers who are yet to attend the security training, the Director General of Shipping, in continuation of Training Circular No.20 of 2013 dated 11.11.2013, Addendum to Training Circular No.20 of 2013 dated 10.12.2013 & Training Circular No.22 of 2013 dated 10.11.2013, has extended the date of validity of the approvals given to the additional batches further w.e.f. 6.4.2014 upto 28.06.2014.
- 4. The intake capacity for these additional batches will be limited to the approved intake per batch of SSO Course, and subject to the terms and conditions as mentioned in Training Circular No.22 of 2013.
