Subject:

Dispensing with the requirement of obtaining prior approval for appointment of Principal/Head of Institute from the Directorate General of Shipping.

The Director General of Shipping issued DGS Order No.5 of 2013 dated 15.3.2013, regarding the faculty approvals, qualifications, age limits, teaching hours and other related matters. The practice of obtaining prior express approvals for the faculties and the instructors from the Academic Councils was discontinued vide para 1.1, Part-1 of the said Order. The practice of obtaining prior express approval for the Principal from the Directorate General of Shipping was continued vide para 1.3 of Part -1 of the said Order.

- 2. The issue of obtaining prior express approval for appointment of the principal has been reviewed by the Directorate. It has now been decided to dispense with the requirement of prior approval of the Directorate General of Shipping for appointment of the principal. Therefore, the Maritime Training Institutes are allowed to appoint the Principal /Head of the Institute, on their own, by strictly adhering to the requirements prescribed with regard to the qualification, maximum age, the teaching hours and the responsibilities, as stated in para 3.8 & 3.9 [Part-3], para 4.2 [Part-4], para 5.1 [Part-5] and para 7.4 [Part-7], prescribed in DGS Order No.5 of 2013. The compliance of the same will be verified by the concerned Recognized Organisation [RO] or jurisdictional Mercantile Marine Department, during the Comprehensive Inspection Programme or the scheduled/unscheduled /course inspections, respectively. The institute shall intimate the appointment of new Principal/Head of Institute, to the Directorate, within 15 days from such appointment.
- 3. In view of the above, para 1.3 of Part-1 of the DGS Order No.5 of 2013 dated 15.3.2013 stands 'deleted' and the DGS Order No.5 of 2013 stands amended accordingly.
