Subject: Partial amendment in the educational qualification for admission in the Pre-sea Electro -Technical Officers Course

Sir

I am directed to state that vide Training Circular No.1 of 2011 dated 10.2.2011, and subsequent Corrigendum dated 12.6.2012 to Training Circular No.1 of 2011, the following educational qualifications have been prescribed by the Directorate, for admission in the Pre-sea Training for Electro Technical Officer's [ETO] course:

- Passed 10+2 with Physics, Chemistry, Mathematics and English as a separate subject, with minimum 50 % marks in English language at 10th or 12th standard exam.
- II. Passed three years' Diploma with 60% marks or four years Degree including lateral entry with 50% marks, in Electrical Engineering, Electronics Engineering, Electronics and Telecommunication / Communication Engineering, or Electronics and Instrumentation or equivalent.
- III. The diploma /degree courses must have been recognized by any State or Central Government or the AICTE.
- 2. The Directorate has been receiving many representations from the degree holders who have completed their Diploma after 10th standard [without completing 10+2] and admitted as a lateral entry into second year of B.E./B.Tech Degree course, thereby unable to fulfill the eligibility criteria mentioned at (I) above.
- 3. The matter has been examined and the Directorate has permitted the admission of such students [mentioned in para 2 above], by condoning the requirement of 10+2 with Physics, chemistry and Maths.

4. In view of the above, those candidates who were admitted in Diploma course on the basis of Matriculation only and went on to complete their B.E./B.Tech degree course as a lateral entry in the 2nd year of the degree on the basis of Diploma, and has secured the degree in the disciplines mentioned at [II] of the eligibility criteria above, are also permitted to be admitted in the ETO course, subject to fulfilling the other eligibility norms and medical fitness as per rules.
