1. This Directorate had issued the guidelines of Comprehensive Inspection Programme (CIP) for institutes conducting pre-sea courses issued vide DGS Order No.25 of 2013 dated 31st December, 2013 and guidelines of Comprehensive Inspection Programme for institutes conducting post sea competency courses issued vide DGS Order No.23 of 2014 dated 29th December, 2014.
2. Attention is invited to the notification dated 5.10.15 [F.No. No.TR/Cir/6(6)/2012-II] informing the constitution of study group for reviewing the CIP checklist for pre-sea training institutes. The study Group has reviewed the same and the process of revising and modifying the assessment checklist, is in the final stage.
3. In view of the above, all the approved maritime training institutes and the approved concerned Recognized Organizations are informed that the CIP for the year 2016 shall be on the basis of revised checklist and instructions thereon, which will be issued shortly.

4. It may be noted by all that CIP inspection for 2016 on the basis of present checklist (Annexure I & II of DGS Order 25 of 2013) will not be accepted, and inspections carried out with the prevailing checklist will have to be repeated again once the revised checklist is notified.
