- 1. The Directorate General of Shipping [DGS], Govt.of India [GoI], has ordered that all the DGS, GoI approved maritime training institutes [MTIs] which conduct the Proficiency in Survival Craft & Rescue Boat (PSCRB) and Fire Prevention and Fire Fighting (FPFF) courses shall, compulsorily, video record (with date and time) all the practical training aspects thereof such as 'lowering and manoevuring of rescue boat', 'mock-up fire fighting' etc., batch wise, and keep the same in their records. Further, such MTIs which also conduct the following courses too need to video record their practical training aspects on the above lines;
 - 1.1 Personal Survival Techniques [PST],
 - 1.2 Augmentation of FPFF [AFPFF] &
 - 1.3 Advance Fire Fighting [AFA].
- 2. The said video recordings, batch-wise, will be checked during the annual inspections and CIP inspections of such institutions. The MTIs approved by the DGS, GoI, but not found in possession of such video recordings will be suspended from the conduct of their approved maritime training courses, in future.

3. This communication is issued with the approval of the Director General of Shipping and Additional Secretary to the Govt.of India, under the powers conferred under Rule 75 [Chapter IX] of the Merchant Shipping (Standards of Training, Certification & Watchkeeping for Seafarers) Rules, 2014, notified under sub-section (4) of sections 78, 87, 88, 98,456,457 & 458 of the Merchant Shipping Act, 1958, as amended.
