- All official members are free to depute any specific officer by proper authorization to attend the meetings of the MLC Compliance Board on regular basis and meetings of the MLC Compliance Board. All such meetings will be recorded and minuted with record thereof.
- The terms of reference of the MLC Compliance Board shall be as follows; 3.
 - 3,1 Reviewing Merchant Shipping (Maritime Labour) Rules, 2016 and the Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 to ensure the recruitment and placement of seafarers adhere to international standards set forth by the MLC 2006 standards, thus safeguarding the rights and welfare of seafarers in the maritime industry.
 - 3.2 To act as advisory board for all the aspects related to the compliance of MLC 2006 outlines in the Merchant Shipping (Maritime Labour) Rules 2016 and Merchant Shipping (Recruitment and Placement of Seafarers) Rules, 2016 to protect the Rights and Interest of seafarers.
 - 3.3 To review RPS agencies inspections, approval processes, monitoring mechanism and suggest changes in system of approval processes.
 - 3.4 To review RPS agencies inspections of Comprehensive Inspection Programmes (CIP) processes and suggest changes in system of the processes.
 - 3.5 To review the recommendations of inspecting authority towards initial approval of RPS agency and suggest the way forward for DSEO.
