Sub: Engagement of Officers retired from Central Government as Consultant PS in National Shipping Board, Mumbai on contract basis.

The Directorate General of Shipping announced Job notification to hire candidates who have recently retired from the post of Gazetted Officer, Central Government Services and are willing for engagement as Consultant on contract basis in National Shipping Board, Mumbai.

2. The officer should have experience in their relevant field and in general working of Government Knowledge of computers is essential. Experience in Shipping matters will be an added qualification.

3. Method of selection: Shortlisted candidates will be called for interview by the selection committee. A selection committee would be formed of the candidates who qualify the Interview and would be engaged as consultant as per the requirement of this Directorate.

4. The terms and conditions of their appointment will be as follows:

- i. Age of Candidate should not be more than 62 years on closing date of application.
- ii. The remuneration payable to Consultants would be **Rs.30,000/- (fixed Rupees Thirty Thousand** only).
- iii. The period of engagement will be initially for **11 months** and is further extendable as per requirement based on their performance,
- iv. They shall not be entitled for perquisite such as HRA, CCA, TA, residential accommodation etc.
- v. No TA/DA would be admissible to them for joining the assignment or on its completion
- vi. During the period of consultancy, the Officer would be required to attend the all important items of works pertaining to National Shipping Board, Mumbai as assigned to by this Directorate from time to time.
- vii. During the period of their assignment with the National Shipping Board and also thereafter, it is likely that they may come across certain information of important/confidential nature. They will not divulge any information gathered by them during the period of their assignment to anyone who is not authorized to know have the same.
