#### M.S.Notice No. 23 of 2012

#### F. No. CR/CDC (1)/Pre-sea/2011

<u>Sub</u>: Revised procedure for application of continuous discharge certificate – cum – seafarers identity document CDC for aspiring seafarers completing DGS approved pre-sea training courses (both long term & short term) – reg.

The DG Shipping (DGS), Govt. of India's circular No. 6 of 2005 (F.No.8(1)/CR/2005) dated 20.04.2005 had drawn out detailed guidelines for the issuance of such CDCs to the candidates who have completed long term pre-sea training courses, of one year duration or more, in DGS approved maritime training institutes (MTIs). The said Circular also sets out that such CDCs shall be forwarded to the MTIs concerned for handing over to the respective candidates after their completion of the relevant pre-sea training course(s). The said CDCs were allowed to be issued to the candidates concerned prior to their completion of the course without the declaration of the final examination results to enable them to proceed to sea, immediately without loss of time. It was also stipulated that the remission of sea service for the competency examinations to be taken by them subsequently shall be considered as per the relevant examination Rules, DGS Circulars/ M.S. (Merchant Shipping) Notices, etc. These CDCs were issued with normal validity of ten years duration.

- 2. Subsequently, by the **M.S Notice No. 28 of 2011** [No: F. CR/CDC (1)/Pre-sea/2011] dated 28.11.11 the validity of such CDCs issued to the candidates completing the long term presea courses had been limited to two years, in order to effectively monitor the details of the sea experience attained by such candidates and the performance of the MTIs concerned as regards to imparting on-board training to their pre-sea trainees.
- 3. The issuance of CDCs for the following long duration DGS approved pre-sea training courses has been considered carefully in the light of the aforesaid DG Shipping Circulars, M.S.Notices, etc., holistically;
- 3.1. One year pre-sea Diploma in Nautical Science, leading to B.Sc. Nautical Science –DNS
- 3.2. 4 years B.Sc in Nautical Technology B. Sc. (NT)
- 3.3. 3 years polyvalent (Dual Certification) course leading to B. Sc. (Maritime Science) B. Sc. (MS)
- 3.4. Bachelor of Maritime Engineering B. E. (ME)
- 3.5. Graduate In Marine Engineering GME
- 3.6. Diploma in Marine Engineering DME
- 3.7. Alternative Training Scheme ATS
- 3.8. Electro Technical Officers ETOs
- 3.9. 3 years B. Sc Degree in Nautical Science B. Sc. (Nautical Science)

- 4. Sub-rule (5) of Rule 4 of the M.S. [CDC] Rules, 2001, specifies that "The Trainee Marine Engineer, Trainee Radio Officers and Deck Cadets, who have completed the prescribed pre-sea training and are eligible to proceed to sea shall also be eligible to apply for issue of CDCs specifying the incumbents rank or category". However, successful completion of any course undergone shall be the criteria for judging the competence of an individual completing the course.
- 5. The MTIs also had been directed there under to submit reports of CDCs distributed to all their candidates respectively, within 15 days of the completion of the course concerned. However, such reports are not being received, invariably, from all the MTIs. In the absence of such reports and the non- cancellation of the CDCs which are not distributed to candidates, the CDC database is bound to project an unrealistic statistics of the valid Indian CDCs issued.
- 6. Considering all the above facts, the following revised procedures are prescribed for applying, preparation and issuance of CDCs to candidates who have successfully completed the said long duration pre-sea training courses.
- 6.1. The existing forms I & II and the procedure of submission thereof by the MTIs are here by modified as follows. The MTIs which conduct the said pre-sea long term training courses shall now submit applications for CDCs for their respective training candidates, online as well as in hardcopy, in the new Form- 1prescribed & enclosed with this Notice (Annexure-1: 4 pages) to the Shipping Master, Govt. Shipping Office (GSO), Mumbai for processing the CDC. Such forms shall be forwarded three clear months prior to the completion of the respective course(s).
- 6.2. The Shipping Master, GSO, Mumbai, shall process the application, and generate the CDCs on his official database, in readiness, in advance.
- 6.3. The MTIs shall forward the result of each of their candidates for successful completion of the given course from the concerned University/Institution as the case may be, on declaration thereof.
- 6.4. The Shipping Master, GSO, Mumbai, shall issue CDCs to only those candidates who have successfully completed the course concerned, only on receipt of the declared course results from the institutions/universities, within seven(7)working days of such receipt and forward the same directly to such successful candidates to their formally recorded/available addresses given in their applications, by speed post, with acknowledgement due, under an intimation to the institution/ university concerned, for record.
- 6.5. The validity of such CDCs issued to the candidates who have successfully undergone the said long duration pre-sea training courses shall be of 10 years duration, in line with the regular CDCs. The M.S.Notice No. 28 of 2011 (No: CR/CDC (1)/Pre-sea/2011) dated 18.11.11 is, therefore, hereby withdrawn, consequently.

7.	The candidates undergoing the DGS approved short term pre-training courses (GP Rating,
	Saloon Rating, etc), shall also submit their applications for CDCs in the said revised Form-1,
	three months prior to the completion of their respective course(s) through the respective
	training institutions and such CDCs shall also be processed in terms of the aforesaid procedures and issued, to reiterate, only to the passed candidates.
