### DGS Order: 17 of 2023

## Subject: Amendments to International Convention on Load Lines 1966 and its applicability– reg.

Whereas, the Government of India has ratified the International Convention on Load Lines 1966 and the Convention entered into force on 21<sup>st</sup> July 1968 through acceptance provided on 19<sup>th</sup> April 1968. Article 1 of the Convention mandates general obligation of the Government to undertake all measures which may be necessary to give effect to the Convention.

Whereas, the Merchant Shipping Act 1958, as amended incorporates the Convention and defines at section 3 (20) as "Load Line Convention" means the International Convention on Load Lines signed in London on the 5th day of April, 1966, as amended from time to time.

Whereas, The Merchant Shipping Act, section 310 to 330 provides legislative provisions and powers for implementation of various requirements under the Load Line Convention on all Indian and foreign vessels operating in Indian waters. The Merchant Shipping Act, section 311 provides powers to make rules regulating the survey of ships for the purpose of assignment and marking of load lines and prescribing the conditions of assignment on which load lines may be assigned. The Merchant Shipping Act, section 436 (1) and (2) provides enforcement provisions.

Whereas, the Government has issued Merchant Shipping (Load Line) Rules, 1979 as a measure to give effect to the Convention. Various amendments to the Rules were brought in during 1982, 1989 and 2001. Further, the government has issued Merchant Shipping Notice 21 of 2013 providing guidance on issuance of Multiple Load Lines.

Whereas, the Government has notified the Load Line Assigning Authority vide Notification dated 07<sup>th</sup> November 1997. The Recognised Organizations (RO) were notified vide notification dated 26<sup>th</sup> December 2014 and as indicated, an agreement is entered into with each RO to carryout surveys and certification as per the Convention.
