Whereas the Directorate vide DGS Order No. 03 of 2023 dated 30.01.2023 has introduced a Committee on Sexual Harassment on Women seafarer at workplace under Section 04 of the Sexual Harassment of Women at Workplace (Prevention, Prohibition & Redress Act, 2013), the Competent Authority has constituted a Complaint Committee for seafarers with immediate effect and until further orders or 02 years, whichever is earlier.
