Training Circular No.19 of 2024

Subject : MEO NCV Grade Certificates of Competency –Course IDs reg.

Vide Training Circular No.17 of 2019 dated 27.11.2019, the Directorate General of Shipping has developed a unique four digit code viz 'Course ID' for each DGS approved maritime courses. The list of the DGS approved maritime courses with its duration and the Course IDs was published at Annexure to the said circular.

2. In partial modification of the Training Circular No.17 of 2019, the following amendments in the Annexure have been done, which are in accordance with DGS Order No.09 of 2024 dated 24.05.2024. Further, as per the said DGS Order, two new bridging courses have been introduced for which new course IDs have been allotted. The same are as given below :

(i) Amendments in the existing list of courses :

Sr.No.of Annexure	Course ID	Amendment
36	3212	The name of the course may be read as "MEO (NCV SEO) Part 'A'" instead of 'MEO Class-III(SEO-NCV)-Part A'
37	3213	The name of the course may be read as "MEO (NCV SEO) Part 'B'" instead of 'MEO Class-III(SEO-NCV)-Part B'
42	3232	The name of the course may be read as "MEO(CEO-NCV)" instead of 'MEO Class-III(CEO-NCV)' & Duration of this course may be read as "2 Months" instead of '4 months'.

(ii) New Courses :

Sr.No.	Name of the course	Duration	Course ID
1	Bridging courses from MEO Class III CEO to MEO Class I NCV [upto 8000 kw other than tankers]	2 weeks	3215
2	Bridging courses from MEO Class III SEO to MEO Class II NCV SEO [upto 8000 kw other than tankers]	1 month	3216

3. It has been observed that two Course IDs for "MEO Class III[CEO-NCV]' course, now to be renamed as "MEO(CEO-NCV)" has been allotted, viz '3232' as per Training Circular 17 of 2019 and '3214' as per DGS Order 40 of 2020. As per MTI module system, the institutes approved for this course are shown under the Course ID 3232 and not under the ID 3214. Therefore, the course ID No.3214, being considered as duplicate, is hereby **de-activated** from the system.

4. It is stated that the new Bridging courses need not follow any new approval process but those Maritime Training Institutes who are approved for the conduct of parents courses viz. MEO(CEO-NCV) or MEO (NCV SEO) shall be approved for the Bridging Course(s) listed at table 2(ii)(1) & 2(ii)(2) as it is carved out from the MEO(CEO-NCV) and MEO (NCV SEO) course respectively. The details of the course syllabus is as per DGS Order No.09 of 2024.

5. This Training Circular enters into force from the date of issuance of this circular.
